Title:	Memorial Tree and Bench Program

Legislation Reference: N/A

**Purpose:** To give individuals the opportunity to purchase a bench or tree in memory of a loved one or to commemorate a special occasion while increasing public enjoyment in the Town's parks and trails.

## **Policy Statement:**

1. The municipality will strive to accommodate requests from individuals with regards to the installation of benches and planting of trees, while ensuring an acceptable physical appearance in the community.

## **Operating Guidelines:**

- 1. Individuals may make a donation to install a new bench with a plaque or have a tree planted in the park of their choice, provided that there is space available
- 2. A donation plaque will be installed on the bench with wording chosen by the donor.
- 3. Installation of benches or trees must contribute to the enjoyment of the parks and may not interfere with accessibility to the park or the regular maintenance of the park.
- 4. The style of bench or tree should adhere to the existing theme or use of the park.
- 5. Donations become public property and are available for everyone's enjoyment. Donors do not have any right to priority of use of their donation.
- 6. Public Works staff will do their best to maintain all features of the parks in good condition and make repairs as needed.
- 7. The donor must complete the Memorial Tree and Bench Application and submit, with payment, to the Town Office. A charitable donation receipt will be issued.
- 8. Administration will work with the donor to find a suitable location.

- 9. The donation covers the cost of the purchase, installation and maintenance of the donation for ten years.
- 10. Tree plantings will take place in the spring or fall. Spring planting requests must be received by March 1 and fall planting requests must be received by August 1.
- 11. If circumstances arise that require a bench or tree be located, the Town will make every effort to advise the donor of the relocation.
- 12. If the town determines that a bench is in poor condition and it has been in place for more than 10 years, it may be removed by the Town.
- 13. Installations are seasonal and are done as weather, ground conditions and staff availability permits.
